LIMIT OF LIABILITY: In the unlikely event that the assigned photographer is unable to perform to the guidelines of this contract due to an injury, illness, act of God, act of terrorism, or other cause beyond the control of John Kalad Photography, the COMPANY will make every effort to secure a replacement. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the EVENT(S).

In the unlikely event that digital files have been lost, stolen, or destroyed for reasons beyond the COMPANY's control, including but not limited to camera, hard drive, or equipment malfunction, the COMPANY liability is limited to the return of all payments received for the EVENT(S).

CAPTURE AND DELIVERY: The COMPANY is not liable to deliver every image taken at the event. The determination of images delivered to the CLIENT is left to the discretion of the COMPANY.

POST PRODUCTION AND EDITING: The final post production and editing styles, effects and overall look of the images are left to the discretion of the COMPANY.

In consideration for value received, please note that by signing this agreement, I hereby give **John Kalad Photography** the absolute right and permission to publish, copyright and use pictures agreed in this contract in which I may be included in whole or in part, composite or retouched for John Kalad Photography at no compensation.

Photos will not be released until balance is paid in full.

Cancellations must be communicated at least 2 weeks in advance from the wedding date.

Failure to cancel within 2 weeks will result in the higher of 50% of wedding package or monies already paid. Wedding Retainers are non-refundable.
