Editing time: Please understand as a photographer my turn around time for your edited images is exactly ONE MONTH from your session date. Due to holidays and other circumstances, rush editing is now available. Rush editing is \$100.00 for your session to be edited in two weeks. This is something I will need to know in advance. It will be added to the session fee if you decide to get a rush on edits. At no time will sessions be edited in less than two weeks. Edits will be posted for viewing ONE MONTH from exact session date unless this rush is purchased at the time session fee is paid. Once galleries are posted if you have any further requests regarding editing, cropping, extensive retouching, etc. additional charges will apply per image. Initial here upon agreement: _____

Rescheduling/Re-shoots/No shows: Requests for rescheduling are granted **only at my discretion**. If someone becomes ill please call me as soon as possible to reschedule. I maintain the right to reschedule if needed due to inclement weather, illness, emergency, etc. After second request to reschedule for reasons other than inclement weather, the session must be shot within 60 days of original session date or the session fee is forfeited and current pricing will apply to new session. Unless there is an emergency situation or bad weather we cannot reschedule during the peek holiday season. If I show up for your session and you are more than 30 minutes late or do not show up at all the session fee is forfeited. If you wish to reschedule the session after this you will need to pay again. *There are NO reschedules or reshoots on ANY mini sessions. These are usually very themed sessions that require hours of setup. They are all scheduled back to back, with no gaps. Cancellations on these days cause gaps where other clients could have purchased a spot. **If you cancel, your session fee is forfeited and will not be applied to any other session. All sales are final.** Initial here upon agreement: _____

***Because it can be distracting, and prevent me from doing my job effectively, use of other cameras is not allowed at the photo session. *You are responsible for covering additional fees and costs related to location choice. Travel includes up to 30 miles round trip from 71111 zip code. If traveling fees apply, they will be added to the initial session fee. Session fee must be paid in full within 24 hours of choosing date in order to hold that date. If not paid within 24 hours the date becomes available to other clients. You will be sent a PayPal invoice for the session that must be paid upon booking in order to hold that date. It is mandatory that this contract be completed, and presented to me before session begins.**

-Families, Children, Couples, Maternity, Lifestyle, etc.: session fee is \$150.00. Limited to 2 outfits, 1 location, 45 minutes.

-Newborns: session fee is \$250.00. This session is ONLY taken 5-12 days after birth. If you plan to book a newborn session please contact me a month prior of expected delivery date so I will have a round about session date for you. For this session I will come to the families home. Maximum 2.5 hours.

The following three sessions, we highly recommend you consider a professional hair and makeup artist.

-Seniors: session fee is \$150.00. Limited to 2 outfits, 1 location, up to 1 hour.

-Bridals: session fee is \$150.00. Limited to 1 location, up to 1 hour.

-Engagements: session fee is \$150.00. Limited to 2 outfits, 1 location, up to 1 hour.
